To accomplish several capital projects as specified and as contracted for on time and on budget, it is recommended by the College Administration that C & S Engineers, Inc., low bidder and most qualified of three bidders, be appointed as the Construction Management Firm for oversight on seven capital projects, for a total amount of \$296,037.04; and that the Herkimer County Legislature be requested to approve a similar resolution.

The College's athletic program finished second for the Daktronics Cup for 2023-2024 and came in as the eighth highest ranked community college in the country.

FOUNDATION & AUXILIARY REPORTS

Foundation:

Mr. Reardon reported on the Foundation annual dinner. The annual Arts and Crafts Fair will be held in November for one day only. Mr. Laino is working on increasing the athletic endowment and has spoken to the Foundation about replacing the College mascot.

Housing:

Revenue is being acquired for Housing through external use of the facilities this summer, with potential use in the fall as well.

NYCCT:

Mr. Gregory announced that two nominations for the annual NYCCT awards program were submitted. Ms. Prymas encouraged attendance from trustees to the NYCCT awards ceremony on Saturday, October 5, 2024 in Saratoga Springs.
